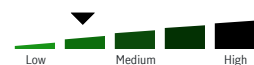

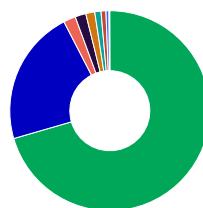

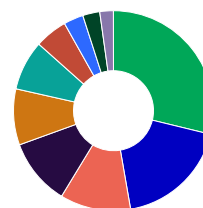

### Geographic Allocation (%)



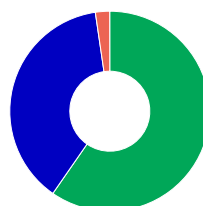

### Sector Allocation (Equities) (%)



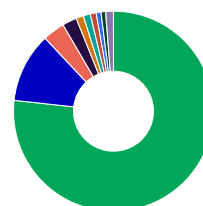
